

# Ally x Unrivaled Sweepstakes

## Official Rules

To enter and participate in this Sweepstakes, you must agree to and abide by these Official Rules.

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. You must have Internet access and an active e-mail account to participate.**

- 1. Eligibility:** The *Ally x Unrivaled Sweepstakes* (the “**Sweepstakes**”) is open only to legal residents of the fifty (50) United States and Washington D.C., who are at least 18 years of age (or the age of majority in the jurisdiction of their residence, whichever is older) and who have an active Ally account and Internet access as of 1/15/26. Employees of Ally Financial Inc. (“**Ally**” or “**Sponsor**”), Probability LLC (the “**Administrator**”), Unrivaled, LLC (“**Unrivaled**”), any organizations responsible for sponsoring, fulfilling, administering the Sweepstakes or supplying the prize (or any element thereof), and each of their respective parent, subsidiary, related and affiliated companies, and the entities owned and operated by those persons (collectively, the “**Promotion Entities**”), and the immediate family and household members of all such foregoing individuals, are not eligible to enter or win. “Immediate family members” shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, regardless of where they live. “Household members” shall mean people who share the same residence at least three (3) months a year, whether related or not. In addition, persons who are currently involved in any capacity with any team in the Unrivaled professional basketball league or the league itself (including but not limited to players, coaches, front office members and their staffs, and investors in the league) are not eligible to enter or win. Potential winner will be required to provide proof of eligibility prior to prize award as discussed below. Void where prohibited.

**Entrants may not have been convicted of a felony or a crime of moral turpitude. By entering, each Sweepstakes entrant (“Entrant”) understands and agrees that, if selected as the potential Grand Prize Winner, he/she will be required to consent to a background check to verify eligibility. Grand Prize Winner’s guest will also be required to consent to a background check. Failure to sign such consents and authorizations and/or to furnish all required information will result in disqualification.**

- 2. Sweepstakes Entry:** The Sweepstakes begins on or about 9:00:00 a.m. Eastern Time (“**ET**”) on January 16, 2026 and ends at 11:59:59 p.m. ET on February 6, 2026 (“**Promotion Period**”). Sponsor’s computer is the official clock for the Sweepstakes.

During the Promotion Period, navigate the Internet to <http://www.ally.com/loyally/unrivaled> (the “**Website**”). On the Website, you must complete the entry form by providing: your full name, e-mail address associated with your Ally account, and phone number where you may be reached during normal business hours (9:00 a.m. ET – 5:00 p.m. ET) on or about February 9, 2026 if your entry is selected as the potential winner in the random drawing.

**CLICK THE CHECK BOX SIGNIFYING THAT YOU MEET THE ELIGIBILITY REQUIREMENTS AND HAVE READ AND AGREE TO THESE OFFICIAL RULES. IF YOU DO NOT CHECK THE BOX INDICATING YOUR AGREEMENT TO THE ABOVE, YOU WILL NOT BE ENTERED IN THE SWEEPSTAKES AND CANNOT WIN THE PRIZE.**

In such event, Sponsor reserves the right to conduct the Sweepstakes and award the prize in a manner which is fair, appropriate and consistent with these Official Rules, as determined by Sponsor in its sole discretion. Notice of termination/modification/suspension of Sweepstakes will be posted on the Website. Without limitation of any other term here, Sponsor and its agencies are not responsible for failed, partial or garbled computer transmissions, technical failures of any kind (including but not limited to electronic malfunction or damage of any network, hardware or software), any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or loss, destruction or unauthorized access to, or alteration of, entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any e-mail or electronic entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to entrant's or any other person's computer or mobile device related to or resulting from participation in this Sweepstakes.

Entrants further agree not to knowingly damage or cause interruption of the Sweepstakes and/or prevent others from participating in the Sweepstakes. 3. **Random Drawing/Odds:** Potential winner will be selected via a random drawing, on or about February 9, 2026 from among all eligible entries received during the Promotion Period. The random drawing will be conducted by Administrator, an independent judging organization, whose decisions are final and binding on all administrative matters related to the Sweepstakes.

**Odds of winning the prize depends on total number of eligible entries received during the Promotion Period.**

4. **Winner Notification:** Potential winners will be notified by e-mail/phone on or about February 9, 2026. Failure to respond to the initial notification within twenty-four (24) hours after transmission to potential winner or return of notification as undeliverable after two (2) attempts will result in disqualification and award of the prize to an alternate winner (time permitting). Potential winner will be required to complete, sign and return within forty-eight (48) hours of transmission, an Affidavit of Eligibility, a Liability Release and Indemnification, and a Publicity Release, where allowed by law and the necessary paperwork for a background check ("**Prize Documents**"). If potential winner does not respond to the initial notification attempt within twenty-four (24) hours after transmission as set forth above, if Prize Documents are not returned to Administrator within the specified time period, if prize notification is returned as non-deliverable, if potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or if potential winner does not accept the prize for any reason, prize may be forfeited and such potential winner may be disqualified. If potential winner is disqualified for any reason, prize will be awarded to an alternate winner selected from all remaining eligible entries received during the Promotion Period (time permitting). In the event of any dispute concerning the identity of any entrant, the entry will be deemed submitted by the natural person who is the authorized holder of the transmitting e-mail account. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

Three (3) grand prizes ("**Grand Prize**") are available to be won: two (2) courtside seats for each first round game of the Unrivaled Basketball League playoffs on Saturday, February 28, 2026 in Miami, FL ("**Games**"); two (2) Courtside Club access passes; entry for the winner and their guest to the pre-game practice session; one (1) post-game on-court photo opportunity; one (1) \$5,000 gift card from bank/financial institution which may be used by winner and guest for expenses related to travel to attend Games (issuer of gift card to be determined in Sponsor's sole discretion; issuer's terms and conditions apply to use of gift card); and one (1) round trip ground transportation to and from winner's hotel/residence and Games. **ARV of each Grand Prize: \$6,080.00.**

Prize Restrictions:

**Winner must be available to attend Games on February 28, 2026; if winner is not able to do so for any reason, prize will be forfeited in its entirety without liability of any kind and an alternate winner may be selected, time permitting.**

Tickets are good only for Games and are also subject to terms and conditions of use, as indicated thereon. Among other things, such terms and conditions set forth winner's right to relief (if any) if one or both of the Games is not played as scheduled for any reason. Winner and guest must also comply with the restrictions of the venue hosting the Games, including its code of guest conduct.

Ground transportation available only if hotel or residence is within a 45-mile radius of the Games. If a winner's hotel/residence is outside the 45-mile radius of the Games, such winner will be solely responsible for their own travel arrangements to attend the Games.

If behavior of winner and/or guest is deemed to be particularly offensive or egregious by Sponsor, Sponsor may pursue legal sanctions against winner and/or guest (as applicable).

All costs and expenses relative to acceptance/use of Grand Prize not specified herein are not included and are solely the winner's responsibility. Without limitation, other than as specified herein, winner and guest are solely responsible for making all travel arrangements to attend Games.

Guest of Grand Prize winner must complete, sign and return a Liability Release and Publicity Release (where lawful) prior to prize award. If guest is a minor, his/her parent/legal guardian must be the Grand Prize winner and a parent/legal guardian must sign the Liability Release and Publicity Release (where lawful) on the guest's behalf.

No cash alternative or Grand Prize substitution will be allowed, except (a) for cash redemption of gift card where required by applicable law and (b) Sponsor reserves the right in its sole discretion to substitute one or more prize elements of equal or greater value for the Grand Prize or portions thereof if Grand Prize listed or portions thereof is/are unavailable for any reason.

Grand Prize must be accepted in its entirety or not at all; and, if any part of the Grand Prize is declined, no alternate prize or compensation will be awarded.

**All federal, state and/or local taxes are the sole responsibility of the Grand Prize winner who will receive an IRS Form 1099 reflecting the value of the Grand Prize.
