Actual Portfolio Performance

Performance returns reflect the results of actual trading managed according to the portfolio model and client specific goals.

The returns are calculated using a time-weighted methodology. Time-weighted reporting compounds daily portfolio-level returns from the period the account had been originally funded until the present time. Reports are intended to inform clients about investment performance on both an absolute basis and as compared to a known benchmark. AIA believes these are appropriate methods to evaluate portfolio performance since they are not sensitive to the contributions or withdrawals the client makes to their account. AIA does not validate performance reports created by systems external to ours, and cannot attest as to whether they are calculated on a uniform and consistent basis.

The returns are calculated net of advisory fees and the deduction of exchange-traded fund ("ETF") internal expenses. No Commissions are charged on eligible securities. Any impacts of federal and state taxes are not included.
